A1. BUSINESSES FOR WHICH MUSIC IS ABSOLUTELY NECESSARY
(Nightclubs, Discos, Shows, Music Halls, Night Stages, Pubs, Beach Clubs etc)
 10% of their gross income, with the minimum amount per year as follows:

Businesses that operate up to 9 months:

80% of the aforementioned fees

Businesses that operate 6 to 9 months:

70% of the aforementioned fees

Businesses that operate less than 6 months but this period is between May and September (summer season):

60% of the aforementioned fees

Businesses that operate less than 6 months but this period is between January and April or October and December (winter season):

50% of the aforementioned fees

Public spaces that operate as bars, cafés, restaurants etc. are exempted and they subject to categories A and B of this tariff table

C1. MALLS

Flat fee of 6.00 € per branch per working day.

C6. HEALTHCARE INSTITUTIONS

Annual flat fee:

Doctors' offices: 200,00 €

Private Clinics – Hospitals, Beauty Salons, Spa, Private Clinics etc: 500,00€

Public hospitals are exempted. Regarding cantinas of private or public hospitals the provisions of B of this tariffs' list apply.

BUSINESSES THAT OPERATE UP TO 7 MONTHS:

70% of the aforementioned fees

BUSINESSES THAT OPERATE UP TO 5 MONTHS:

50% of the aforementioned fees

D. CULTURAL SPACES

D1. THEATERS - CINEMAS

(Halls and public spaces)

Annual flat fee:

Up to 500 seats	200€
501-1000 seats	400€
1001-2000 seats	800€
2001- 3000 seats	1000€
For every additional 1000 seats	+200€

Public spaces that operate as bars, cafés, restaurants etc. are exempted and they subject to categories A and B of this tariff table.

D2. MUSEUMS - GALLERIES

(Halls and public spaces)

100€/ /permanent exhibition per year
 10€/periodical exhibition for a period that lasts less than ten weeks per year.

(Public spaces that operate as bars, cafés, restaurants etc. are exempted and they subject to categories A and B of this tariff table. In case of public events, an extra fee according to category E of this tariff table is applied)

D3. CULTURAL MULTIPLEXES

(Halls and public spaces)

D3b. CULTURAL MULTIPLEXES – SPIRITUAL CENTERS – CULTURAL CENTERS

0,01€ per ticket with 3.500,00€ minimum amount per year

If the number of tickets cannot be determined, the annual flat fee applies.



Public spaces that operate as bars, cafés, restaurants etc. are exempted and they subject to categories A and B of this tariff table. In case of public events with DJ or MC sets, an extra fee according to category E of this tariff table is applied)

 Business offices using recorded music besides the rooms for customer service – annual flat fee: 50.00€ for every 300 m2
 Parking Spaces – annual flat fee: 1,500.00€

2000€/ hour of parade with a minimum fee of 2,000.00€ per event

OTHER EVENTS (SEASONAL EVENTS, CIRCUS, OPENING AND CLOSING CEREMONY EVENTS ETC.): 1.500€/Event

H. CALL CENTERS

Annual Flat Fee as follows:

Up to 5 lines	150,00 €
6-20 lines	200,00 €
21-50 lines	250,00 €
Over 51 lines	300,00 €

CLARIFICATIONS

- 24% Tax is not included in the aforementioned fees
- In case the fee is not paid during the year that it concerns, the fee is charged with operating expenses and costs
- Public areas of hotels and guesthouses subject to the equivalent categories of this tariff table.
- Businesses with more than one branch are obliged to pay the aforementioned fees for each branch separately.
